Sir,

I, the undersigned, a victim and refugee taking relief / shelter at Tuibuong, Churachandpur at present have the honour to state the following for your kind intervention and favourable action that, on 3rd May 2023 at around 8:00 -9:00PM, unknown mobs from the Meitei community armed with deadly sophisticated weapons came and forcefully vandalized and looted our Restaurant namely L.K. Restaurant situated at Torbung Bazar, Churachandpur, thereby burning our Restaurant and all the goods inside the Restaurant which was newly constructed, the description of which is detailed hereunder :-

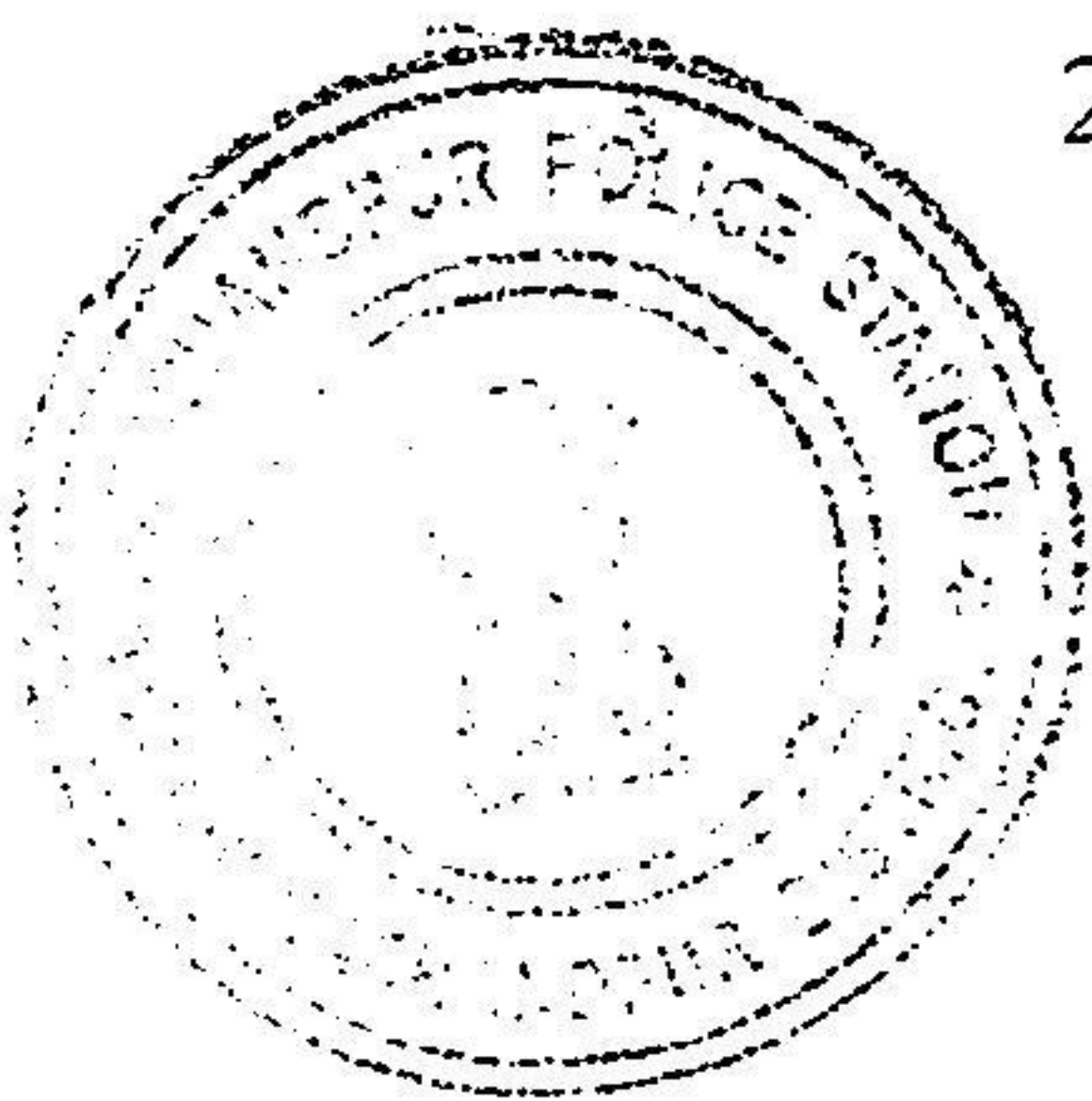
(1) Moveable property – (i) All the goods inside the Restaurant

That, the estimated value of movable property destroyed, looted and burnt is estimated to be worth approximately Rs. 7,00,000/- (Rupees Seven lakh) only.

Being the victim, I am filing this report and request you to kindly take necessary legal action against the said culprits as per law.
