

We are writing this letter to report to you sir that on 07/05/2023 @ 07:30 AM we were being evacuated and rescued due to ethnic clash between Kuki & Meitei and leaving behind all our valuable assets like 1) Samsung Galaxy book 3 Pro 360 intel 13th Gen i7 Evo TM 40.62 CM (16") touch screen, value about Rs. 1,79,999/-, 2) Mattress brand sleep well 2(Two) nos. value about Rs. 20,000/-, 3) blanket 2(Two) nos. value about Rs. 5,600, 4) Music sound system Sony brand 1(One) no. value about Rs. 10,000/- & 5) colour Smart LED TV 55" inch LG brand 1(One) no. value about Rs. 45,000/- & other household items and one motor bike red in colour bearing R/No. MN05B8690, Engine No. JEZCFJ78953, Chassis No. MD2A82DZ2GCK00074 registered in the name of Khwairakpam Binodkumar Singh & the value of the bike is around Rs. 1,05,000/- from our quarter No. Type-II/C-4 Leimatak Power House Colony which is allotted to us.

That, on 28/09/2023 at around 2:24 PM we received an information that our left-out property above mention were stolen & looted by some unknown persons suspected to be Kuki resident of Leimatak. The approximate value of the stolen & looted items is about Rs. 5,70,000/- (Five Lakhs & Seventy Thousand). We request you to kindly registered the complaint and look into this matter as soon as possible.


