I hereby write this letter to draw your attention that in the past few days i.e., on the 3rd of May 2023 @ 6:30 I Mr. Lamneimang Vaiphei aged about 68 years S/o (L) Soitin was attacked by a group of Meetei/Meitei goons at my residential home, owned and registered in my name situated at T. Khawvaiphei, Kangvai SDO, P.S/P.O. Churachandpur, 795128.

These criminal broke open the gate and destroy my residential Kutcha home and one Four Wheel Repairing Workshop situated at the location mentioned hereinabove located within the said premise, all what is within the above named kutcha house and four wheel repairing workshop structure itself, was looted, vandalized and gutted/burnt down, a total loss estimated to be at an an amount of Rs. 7,00,000/-(Rupees Seven Lakh) Only by the said meetei/meitei goons was gutted, vandalized and looted.

Fortunately, me and my family members managed to escaped from these criminals who even tried to kill or burn them alive, and now currently taking refuge at EBC, Relief Camp Hiangtam Lamka, Churachandpur.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
