

Report on looting, vandalism and burning of house and its assets/properties.

Sir,

I hereby write this letter to draw your attention that in the past few days i.e., on the 3rd of May 2023 @ 6:30 I Ms. Lhingkhonei aged about 35 years W/o Mimin was attacked by a group of Meetei/Meitei goons at my residential home, owned and registered in my father-in-law (L) ST Khuppa, situated at T. Khawvaiphei, Kangvai SDO, P.S/P.O. Churachandpur, 795128.

These criminal broke open the gate and destroy my residential Kutcha home and one Chappal Manufacturing Workshop situated at the location mentioned hereinabove located within the said premise, all what is within the above mentioned structured, was looted, vandalized and gutted/burnt down, a total loss estimated to be at an an amount of Rs. 15,00,000/- (Rupees Fifteen Lakh) Only by the said meetei/meitei goons.

Fortunately, me and my family members managed to escaped from these criminals who even tried to kill or burn them alive, and now currently taking refuge at Thingkangphai, Churachandpur.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
