I am to bring to your notice that on the 3<sup>rd</sup> of May, 2023 at around 4.30 PM. My residence (Owned/Rented) located at Centenary Veng, Kangvai was attacked, destroyed, looted and burned by a Group of Meetei/Meiteis.

These criminals broke open my gate(s), destroyed and looted every valuable property from my "Owned/Rental" House, and premises worth Rupees 699000 (Approx.) and they burnt down all the remaining things.

Therefore, with outmost Respect I request you to take strong actions against the perpetrators by registering an FIR under relevant sections of the Indian Penal Code.
