

We would like to state the following few lines for your kind attention and necessary action.


That, on 07/05/2023, we had left our quarter no. Type- 2/A-6, Leimatak which is allotted to us and we left all our belonging like valuable household items, kitchen items, apparels, tools and Machines for house electric fitting works, electronic goods, LED TV sets, gold ornaments & some cash amount approx. Rs. 20,000/- inside my quarter at Leimatak with locked and key. We are the contract NHPC employee posted at Power House Station NHPC Ltd, Leimatak for the last 10 years.

However, on 25/09/2023 at around 11:12 AM we were being informed that our quarter lock had been broken and looted, stolen all our left-out household items by some unknown persons suspected to be Kuki residence of Leimatak. The approximate value of the looted, stolen items is around Rs. 10,00,000/-(Ten Lakhs). We can not report timely as we were very busy in our duty at NHPC Loktak.

Hence, we sincerely request you to kindly take up necessary action.
