The mob vandalised and damaged two cars which were kept for repairing bearing no. ① Honda City MN01X7087 (owner Pathe Singait) ② Fiat Figo MN02 1045 (owner Thang Khopao) and ③ Vespa Scooter MN02 3533 (owner Lalvethang).

Later in the night around 6:30 pm - 7:00 pm the unruly mob set on fire the workshop. The given list below are the tools that are lost or damaged -

- 1) Spray Pump 500 litres capacity.
- 2) Spray Pump 200 litres capacity.
- 3) Paint 5 litres, thinner 20 litre.
- 4) Spray Gun - 5 piece
- 5) Vibrator Plainer - 2 piece.
- 6) Heavy hydraulic jack - 2 piece.
- 7) Light hydraulic jack - 2 piece.
- 8) Welding machine - 1 piece.
- 9) MIG welding machine - 1 piece.

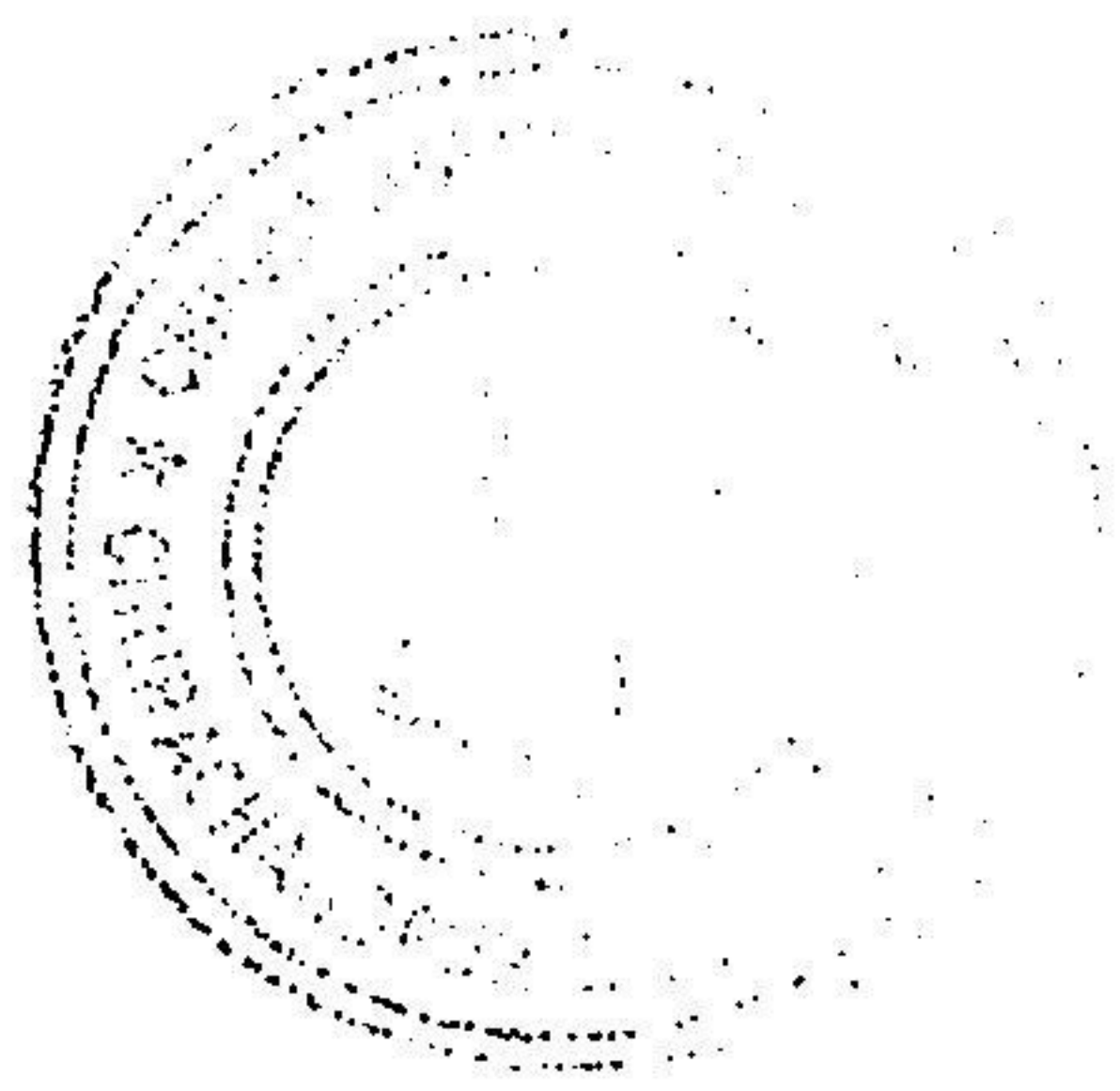
