Sir,

With due respect, I would like to report that on 03-05-2023
around 3:00 - 4:00 pm a group of unruly mob numbering
in hundreds attacked our home at Kangrai Bazaar. The mob
pelted stones then entered our compound after forcibly breaking
the main gate. They ransacked and vandalised properties
kept in the compound, they broke the window panes and
precisely kicking the main front door with the intention of
entering and inflict harm to the occupants. The goons were
armed with deadly weapons like iron rods, daxes and
sticks. Their first attempt was unsuccessful. In their second
attempt, around 6:30pm - 7:00pm while we took shelter
at the Kangrai Assam Rifles Camp, our house was ransacked
then burnt along with our two rice - barns.

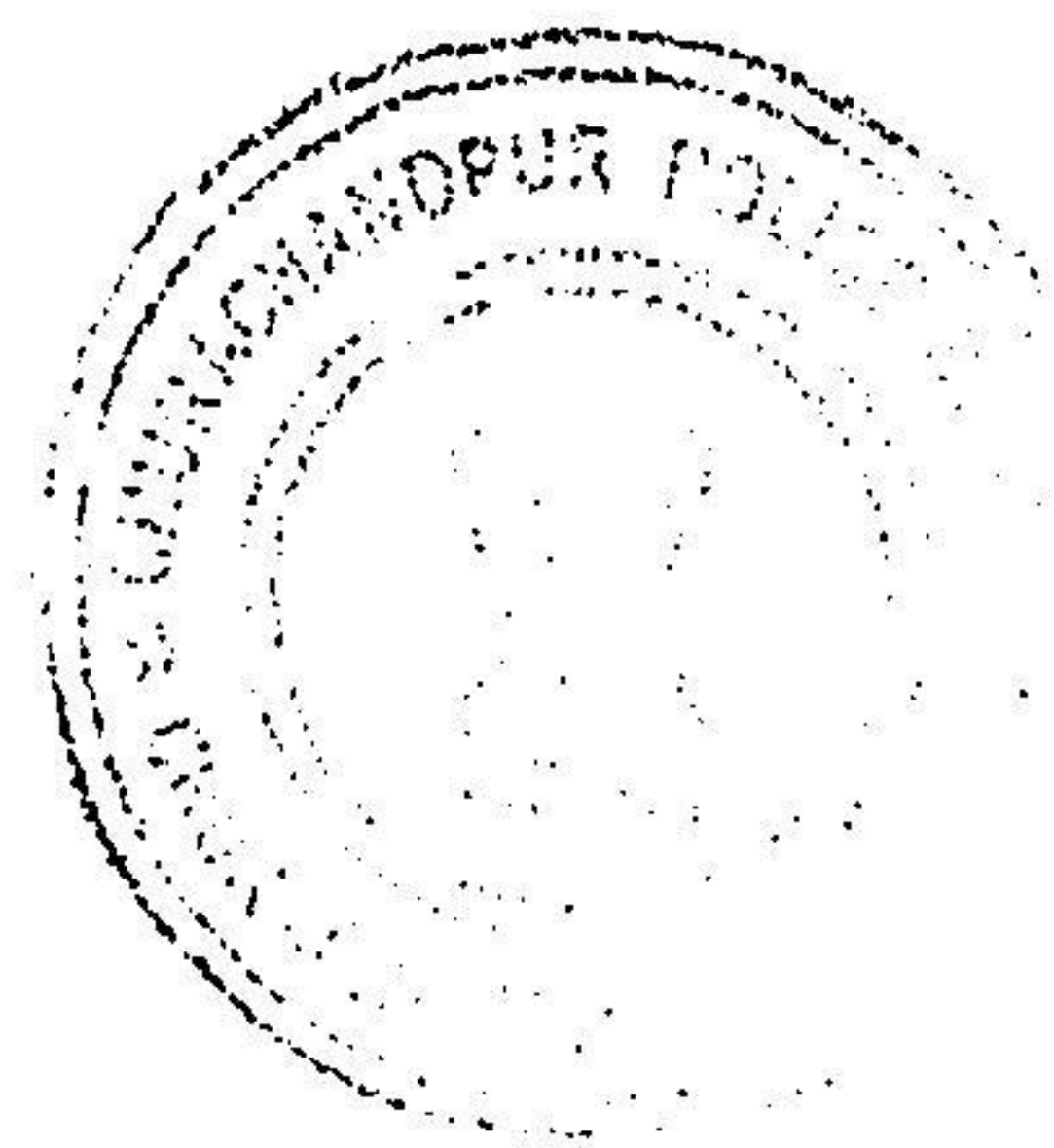
Sir, in this regard, I would like you to kindly
