


These criminals broke open my gate(s), destroyed and looted every valuable property from my "Owned / Rental" House, and premises worth Rupees 20,00,000/- (Approx.) and they burnt down all the remaining things.

Therefore, with utmost Respect I request you to take strong actions against the perpetrators by **registering an FIR** under relevant sections of the Indian Penal Code.
