Subject :- Report against Arson attack of moveable and immovable properties that took place on 3th May, 2023 at about 5:00 to 6:00 pm at Torbung Bazar, P.O. & P.S. Churachandpur.

Sir,

I, the undersigned, a victim have the honour to state the following for your kind intervention and favourable action that, on 3th May 2023 at around 5:00 to 6:00 pm, unknown mobs from the Meitei community armed with deadly sophisticated weapons came and forcefully vandalized and looted our hotel, thereby burning all the remaining unlooted items our hotel the description of which is detailed hereunder :-

(1) Immovable property – The hotel building itself (Sasang Fast Food)

(2) Moveable property – (i) All the goods inside the hotel including the furniture and cooking utensils etc

That, the estimated value of both the moveable and immovable property destroyed, looted and burnt is estimated to be worth approximately Rs. 4,00,0000/- (Rupees ^{Forty} Four Lakhs) only.

Being the victim, I am filing this report and therefore request you to kindly take necessary legal action against the said culprits as per law.
