

Sir,

With due respect, I would like to report and register a cognizable offence carried out against me and my families ~~on the morning~~ of 3rd May, 2023 at around 7:30 pm by Meitei community, who were armed with sophisticated weapons like AK's, Rifles, Pistol, Machette and Knife whom were suspected to be instigated and abated by Meitei Leepun and Arambai Tenggol of valley based CSOs.

Due to such attacked carried out against me and my families, being in state of vulnerable. We had fled from our resident i.e. Torbung, PO, PS and District- Churachandpur.

As such, we have been taking shelter at B. Vengnon KBC Relief Camp. Our family comprises of Male-2 and Female-2 in total 4 members.

On inquiry, my house was ransacked, torched and burnt to ground. Properties were looted and taken away.

Therefore, I seek your kind intervention to register an FIR against the culprit and instigator who abate to carried out such heinous attack against me and my families for the end of justice.
