With due respect, I would like to state the following few lines for your kind attention.

That, I am employed as Home Guard and posted at Leimatak Power Station since the last 27 years and my quarter number is Type-II/21. Due to the present communal clash in Manipur, I left my quarter on 04/05/2023 leaving behind all my household items, kitchen items, some cash, gold, as well as my Maruti 800 bearing reg. no AS 25C4384 with engine no. 3387419 and chassis no. 2375639 at my quarter.

However, on 18/10/2023 at around 5:30 PM one of my friends from Leimatak informed me that all my household items, my kitchen items, cash and my Maruti 800 which I have left amounting to around Rs 10,50,000(Ten Lakhs Fifty thousand) at my quarter has been stolen by some unidentified persons suspected to be of Kuki miscreants.

Hence, I sincerely request you to kindly take up necessary action.
