With due respect, I would like to state the following few lines for your kind attention.

That, I am a contract employee at Leimatak Power Station NHPC Ltd since the last 11 years and my quarter number is Type- II/G-19. Due to the present communal clash in Manipur, I left my quarter on 07/05/2023 leaving behind all my household items, kitchen items, some cash, gold, at my quarter.

However, on 20/10/2023 at around 1:30 PM one of my friends from Leimatak informed me that all my household items, my kitchen items, cash which I have left amounting to around Rs 9,50,000(Nine Lakhs Fifty thousand) at my quarter has been stolen by some unidentified persons suspected to be of Kuki miscreants.

Hence, I sincerely request you to kindly take up necessary action.
