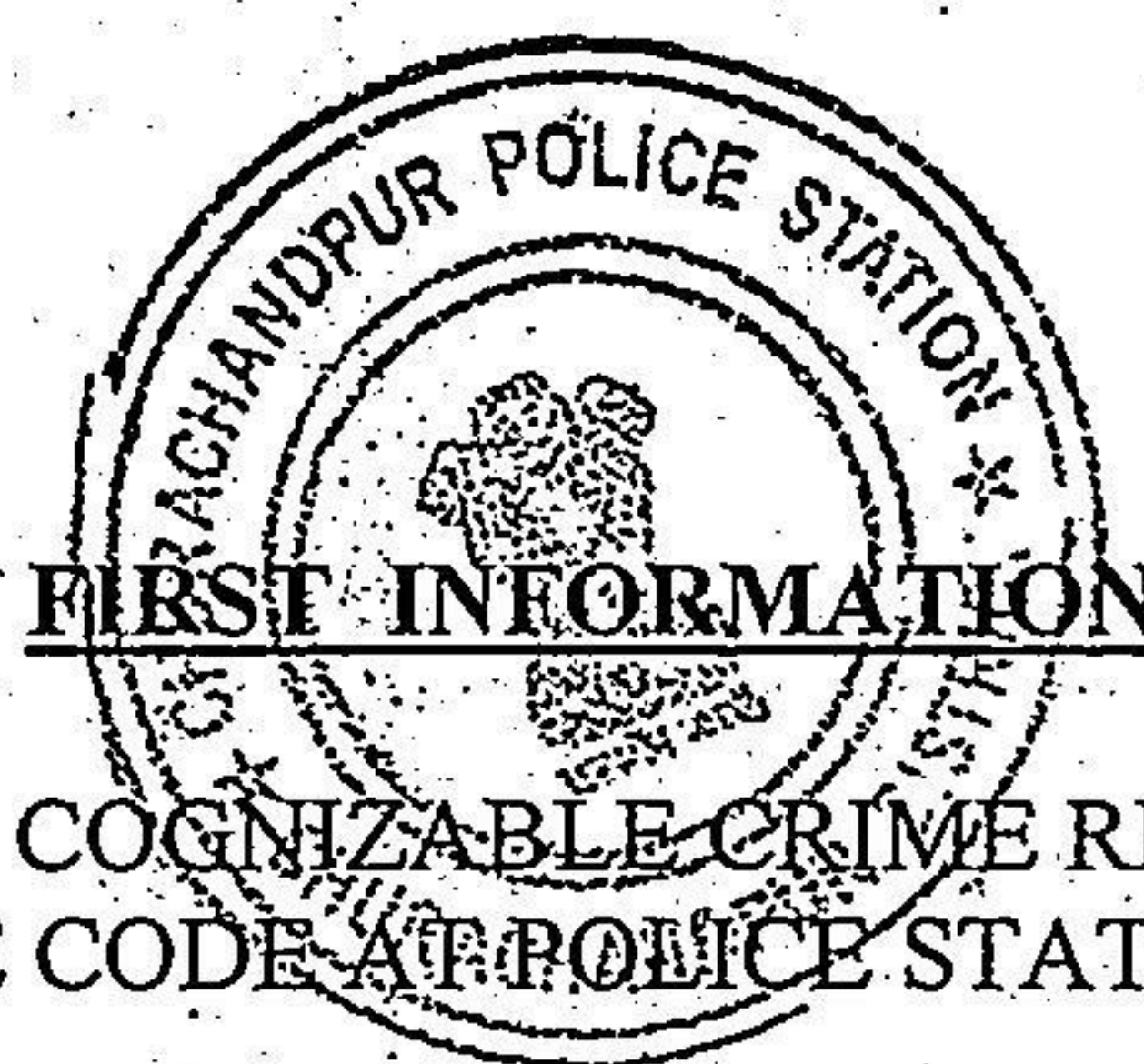

Subject: A complaint application for taking a necessary action for causing injury to personal life and property of the villagers caused by the Tribal Solidarity Rally Organized by the ATSUM (All Tribal Students Union Manipur) which were followed by violence by Kuki on dated 3<sup>rd</sup> May 2023 with combat dresses and sophisticated weapons, burning down/ destroying my house/ shop located at *Charachandpur Khuga Jampak Meitei Leikai* and looting all the valuable items on *3<sup>rd</sup>* May 2023.

Respected sir / Madam,

I the Undersigned have the honour to state that large number of Innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of *Charachandpur Khuga Jampak Meitei Leikai* on *3<sup>rd</sup>* May 2023 at around *3:30 pm* the said unidentified groups vandalised/burnt down my house/shop and looted all valuable items. *I have lost a sum of Rs. 7,80,000/-*
