Subject: Enquiry Report

Sir,

As endorsed to me, I would like to submit the details of the enquiry report in C/W with the missing report, Missing no. 2/LTK-PS/2023 dtd 14/11/2023 Vide Gd Entry No 16/11/2023 dtd 14/11/2023.

That, on 14/11/2023 at around 11:30 AM, a missing report was filed by Pukhrambam (N) Angom (O) Madhabi Devi (47) of Ningthoukhong Awang Khunou Ward no 1. in c/w the missing of her father namely Pukhrambam Birchandra Singh (75) S/O (L) P Khamba Singh and step mother SagoIshem NingoI Pishakmacha Devi (78) D/O (L) Mani Singh of Ningthoukhong Ward no 8. As per her report, both of them have been staying at Leimatak Tumjangphai Village for many years until when their phones were switch off 3/4 days before the missing report was filed.

When enquiring of the two missing individuals, it is learnt that Pukhrambam Birchandra Singh has two wives and a daughter namely P. Madhabi Devi from his first wife (L) P. Latri Devi of Ningthoukhong ward no 8, however he (P. Birchandra Singh) has no children from his second wife Sagolshem Pishakmacha Devi. After the daughter was born, P Birchandra Singh left his first wife and her daughter alone at Ningthoukhong. He then sells off his land/plot at Ningthoukhong ward no 8 and shifted to Ningthoukhong ward no 2 with his second wife (S. Pishakmacha Devi). Later, again he sold his land/plot at Ningthoukhong ward no 2 and then they decided to move at Leimatak permanently. Hence, they were staying at Leimatak Tumjangphai Village.

After staying at Leimatak for some years, P. Birchandra Singh joined NHPC staff and then, they were staying in the quarter at New Colony Loktak project. After his retirement, both of them decided to move back to Leimatak side.

During the course of investigation, on 3rd May 2023 as the communal clash started, information was received that people of Meitei community were staying at Leimtak area both staffs of NHPC as well as civilians. On 7th May 2023, a rescue mission was sent to Leimatak to get all the Meitei community however, it is learnt that both the missing persons (couple) did not turn up.

As per reports from both the family sides of P. Birchandra Singh and his wife, they were in touch with them frequently through mobile phone. Both the couple told that, the village chief is taking care of them by providing foods, medicines, clothes etc. The village chief also told them that they will be protected as they have become part of his family and no harm will come to them. Hence, they refuse to come out of Leimatak Tumjangphai village even after repeated request from their family side. Further into the investigation it is learnt that the last time they spoke was on 8/11/2023 and after which their phones were turn off till date.

On further enquiry, SP-BPR sent a msg vide mgs signal no C-7/4/SP-BPR/2023/C/L/13139 dtd 15/11/2023 to SP-CCP to conduct an enquiry in c/w the missing case of Loktak PS (Missing case no 2/LTK-PS/2023 dtd 14/11/2023). The enquiry reported by Shri Thanjapao Vaiphei, MPS, DSP-CCP Churachandpur to SP-CCP has been forwarded to SP-BPR vide SP-CCP msg no C9/1(C/Riot ST & M) SP-CCP/2023/5527 dtd 16/11/2023 which is further endorsed to OC Loktak PS vide SP-BPR Endst no C/7/4/SP-BPR/2023(C/C)13201. As per enquiry report submitted by Thangjapao Vaiphei DSP-CCP, it is said that the missing couple were seen in Tumjangphai Village and neighbouring areas before the beginning of the present violence and after the eruption of the violence, they remained in the Tumjangphai Village.

On examination of Nehsei Haokip @ Seiboi (49) S/O Thangkam Haokip (Contact no. 8729897938) 2nd son of Chief of Tumjangphai Village, he stated that the couple had moved into the village during March 2023 and asked to settle in the village, as his father is a good old friend of the elderly man, they were allowed to settle. They occupy a buffalo shed situated in the lowest part of the village. Then the village repaired the shed to fit for settlement. Mr. Pukhrambam Birchandra was seen playing with a pet dog named Maya of Janminthang @ Minthang youngest son of the chief, every morning. However, on the morning of 08/11/2023 the elderly man was not seen playing with the dog. Mr. Nehsei on curiosity went to their house to enquire. He found the gate and door opened. He called them loud "Pabung Pabung" but there was no response. So, he went inside the house and found no one inside. He then asked the local people and nearby villagers. But nobody could give any information about the elderly couple. His father namely Thangkam Haokip has manned two villages but due to his health and age condition he entrusted Tumjangphai village to his eldest son namely Dongkai Haokip and he himself looked after L Thingphai village. So, he seldom comes and stayed at Tumjangphai village. On further examination of Mr Nehsei Haokip he suspected that the missing elderly couple might have been abducted by some unknow miscreants in the intervening night of 7th and 8th November 2023.

In the light of the above facts and circumstances, it is highly suspected that the missing person might have been abducted by Unknown Kuki miscreants. So, it is requested that a regular FIR be initiated into the matter and thoroughly investigated into.
