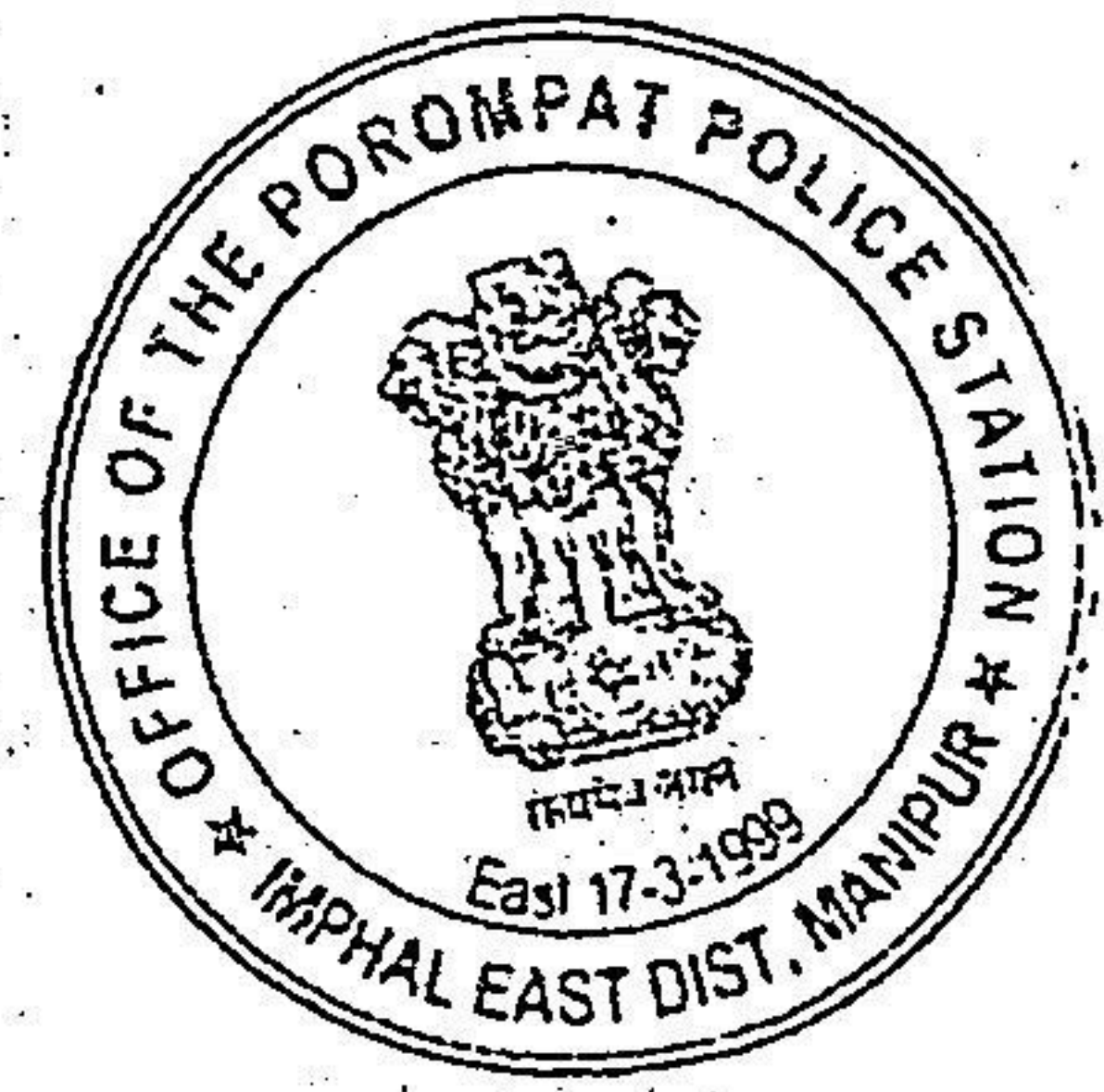

Respected sir / Madam,

I the Undersigned have the honour to state that large number of Innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Churachandpur Khuga Jampak Meitei Likai on 3rd May 2023 at around 3:30 p.m. the said unidentified groups vandalised/burnt down my house/shop and looted all valuable items. I have lost a sum of Rs. 12,96,000/-

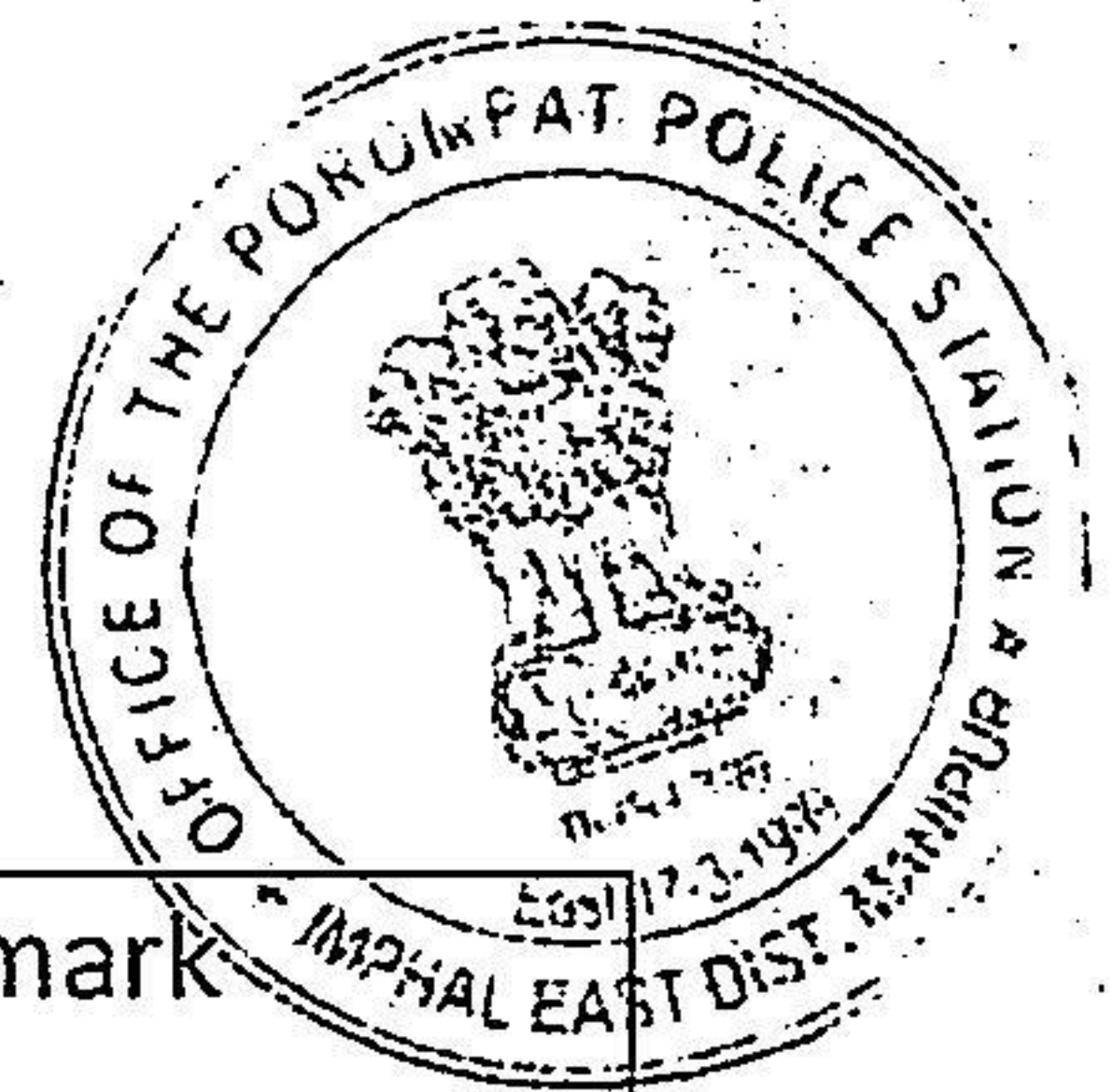
