I, undersigned have the honour to state that large number of innumerable unidentified group of people belong to KUKI Community with deadly weapons and sophisticated arms including KUKI militants groups stormed to all MEITEI inhabited areas of Churachandpur town on 3rd day of May at around 4:30pm. The said unidentified groups vandalized/burnt down my house and shop and looted all valuables items such as Television, wooden almirah, two steel godrej, refrigerator, washing machine, wooden sofa set, three beds, three gas cylinder, inverter and battery, cookeries items, gold includes necklace, one pair earring, two rings, and cash amount of ten thousand (10,000), groceries items to be sold and electronics items from shop such as fan, T.V, rice cooker, inverter, refrigerator etc. In that unfortunate incident, I have lost average total amount of Rs. 50,00,00 (fifty lakh).

After the said unfortunated incident/mob violent, my family are felling our village and my family is taking shelter at a relative resident named as Laishram Lokendro Singh of Kongba Laishram Leikai, Ayangpalli Road Heinoubon, Imphal East District, Imphal Manipur 795005.

I, therefore, prayed and request that the respected Sir may kindly initiate and take necessary legal action(s) against the accused persons involved in the said inhuman acts and heinous crime committed by the accused person and persons involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary action(s).
