I have the honour to report that on 4th June, 2023 at @ 4:30 pm, a large number of unruly (Kuki) mobs stormed at Khumujamba Meitei Leikai, Churuchandpur and set on fire all the houses belonging to Meitei community. In that, three kutcha houses and two pucca building constructed on the Old Patta No. 337/New Patta No. 721 with Dag No. 1059/1207 standing in the name of my father Nandeibam Ibopishak has been reduced to ashes. Moreover, about 15 mohor gold ornaments, a sum of about Rs. 10,00,000/- (ten lacs) in cash, important documents and other household articles amounting approximately about 1 (one) crore were also reduced to ashes in the inferno. I could not report in time as I was stuck at the relief camp located at SANTI CLUB, Moirang Khunou Mamang Sabal, Bishnupur, Manipur.

Therefore, it is requested to kindly take up necessary action as per the law of the land.
