Respected Sir,

I have the honour to report you that on date 04/05/2023 at about 11:30 am, a group of approximately 2000 people of kuki tribe have entire at my rented house located at Churachandpur Khumujamba Meitei Leikai and have burnt, attacked and destroyed my rented house with 5 (five) rooms, asset and properties. The mob was armed with spades, axes, Sticks, and other deadly weapons and they have also stolen away 1 car i20 Asta o 12 Kappa MT Starry Night in colour bearing Regd. No. MN01 AS4658, 2 Activa, 1 wrestling machine, 3 Gas Cylinder, 1 Refrigerator, 1 Nescafe machine, and the total amount of the burnt and lost articles is about Rs. 50 lakhs.

We request your good self to intervene in this matter urgently and protect our land and property and our life and limb from any further loss or damage. You are also requested to register an FIR and submit the computation of the loss to our property mentioned here, to any appropriate body of the state government to grant us the compensation that we need to rebuild our lives.

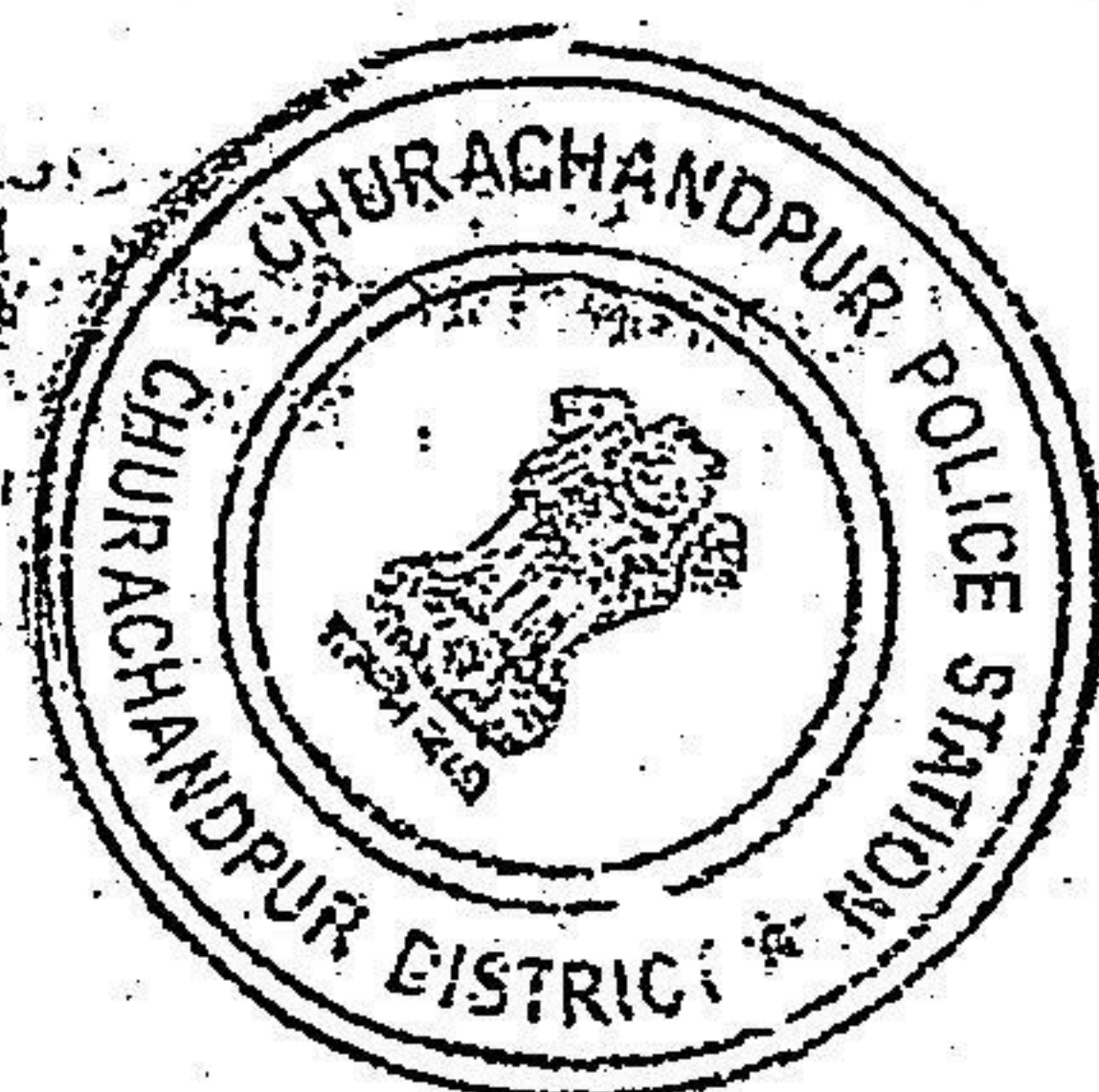
