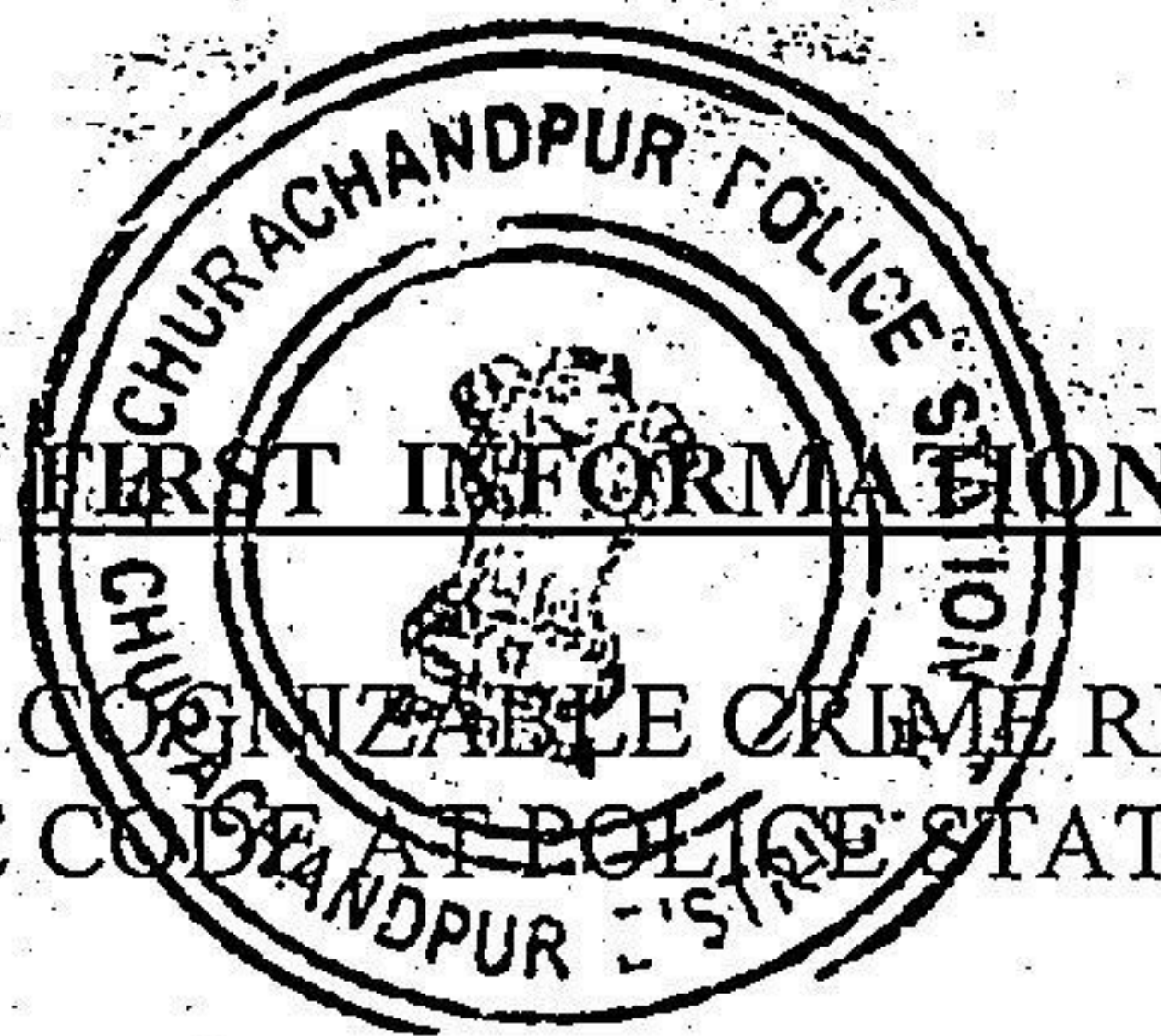

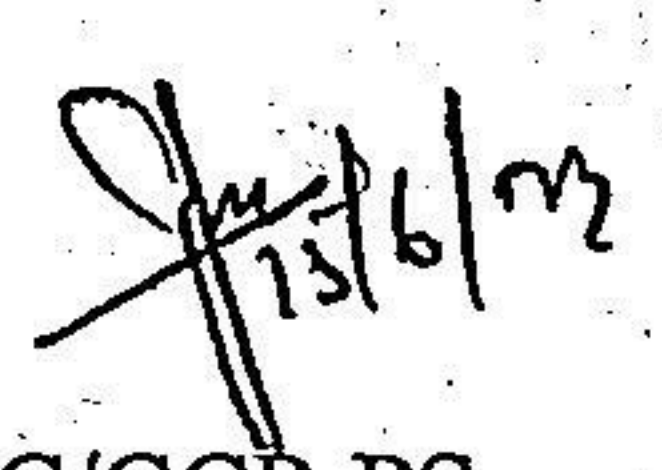

Subject: Report

Respected Sir,

I have the honour to report you that on date 03/05/2023 at around 5:00 pm, a group of people belonging to kuki tribe including Kuki militants group have entire at my house located at Old Bazar Zou Veng, PS- Churachandpur, District - Churachandpur, Manipur and have burnt, attacked and destroyed my house, asset and properties which left me and my family homeless. The mob was armed with spades, axes, Sticks and other deadly weapons. They also forcefully took away some domestic animals including 30 chickens, 10 bags of rice and 1 heavy duty motor cycle etc. The approximate value of the burnt and lost items is about Rs. 8 lakhs. I along with my family members (in total 7 persons) fled from our house for survival and presently took sheltered at Andro Loupaochum girl's Schedule Caste Hostel relief camp.

I, request your good self to intervene in this matter urgently and protect our property and our life and limb from any further loss or damage. You are also requested to register an FIR and submit to any appropriate body of the state government to grant us the compensation that we need to rebuild our lives.
