As a result of which I along with my family members left the residential area and now staying at the Relief Camp, Laphupat Tera High School Govt. Aided Laphupat Tera. Due to the incident my household properties worth Rs. 750000 Lakhs were damaged. We could not report the matter to Churchandpur Police Station due to the present Communal crisis.

You are therefore requested to take up the further necessary actions against the Culprits.
