Sir,

I have the honour to state that on 04/05/2023 at @ 8.15PM some unknown persons suspected to be Kuki's numbering about 60-70 persons having daos, Catapults and sword with full Arms dismantled my rent house since last 10 yrs situated at Khuga Tampak Zouveng, Churachandpur, District P.O/P.S - Churachandpur and in addition to this they also tried to attack us and destroy my house properties by using deadly weapons.

As a result of which I along with my family members left the residential area and now staying at the Relief Camp, Laphupat Tera High School Govt. Aided Laphupat Tera. Due to the incident my household properties worth Rs. 750000 Lakhs were damaged. We could not report the matter to Churachandpur Police Station due to the present Communal crisis.

You are therefore requested to take up the further necessary actions against the Culprits.
