

That, on 07/05/2023, due to present communal Ethnic Clash in Manipur, I had left my quarter mention above leaving all my belongings at the mention quarter like house hold materials, including kitchen items, electronic items, furniture items, family cloths items, equipment and tools.

On 19/11/2023 at around 11:40 AM, I came to know that my all left out belongings were looted and destroyed my quarter mention above by unknown persons suspected to be Kuki resident of Leimatak & Kuki militants. The approximate value of my looted items Rs. 7,00,000/- (Seven Lakhs).

Hence, I sincerely request you to kindly take up necessary legal action against the culprit.


