I have the honour to state that on 04/05/2023 at @ 8.30PM some unknown persons suspected to be Kuki's numbering about 60-70 persons having daos, Catapults and sword with full Arms dismantled situated at Torbung Bangla Torbung Churachandpur District P.O/P.S – Churachandpur and in addition to this they also tried to attack us^f destroy and firing my house by using deadly weapons.

As a result of which I along with my family members left the residential area and now staying at the Relief Camp, Laphupat Tera High School Govt. Aided Laphupat Tera. Due to the incident my household properties worth Rs. 2782000 Lakhs were damaged. We could not report the matter to Churachandpur Police Station due to the present Communal crisis.

You are therefore requested to take up the further necessary actions against the Culprits.
