I have the honour to state that on 04/05/2023 at @ 8.15PM some unknown persons suspected to be Kuki's numbering about 80-90 persons having daos, Catapults and sword with full Arms dismantled situated at Khuga Tampak Meitei Leikai Churchandpur District P.O/P.S – Churchandpur and in addition to this they also tried to attack us destroy & firing my house properties by using deadly weapons.

As a result of which I along with my family members left the residential area and now staying at the Relief Camp, Laphupat Tera High School (Govt. Aided) Laphupat Tera. Due to the incident my household properties worth Rs.65 30000 Lakhs(including house) were damaged. We could not report the matter to Churchandpur Police Station due to the present Communal crisis.

You are therefore requested to take up the further necessary actions against the Culprits.
