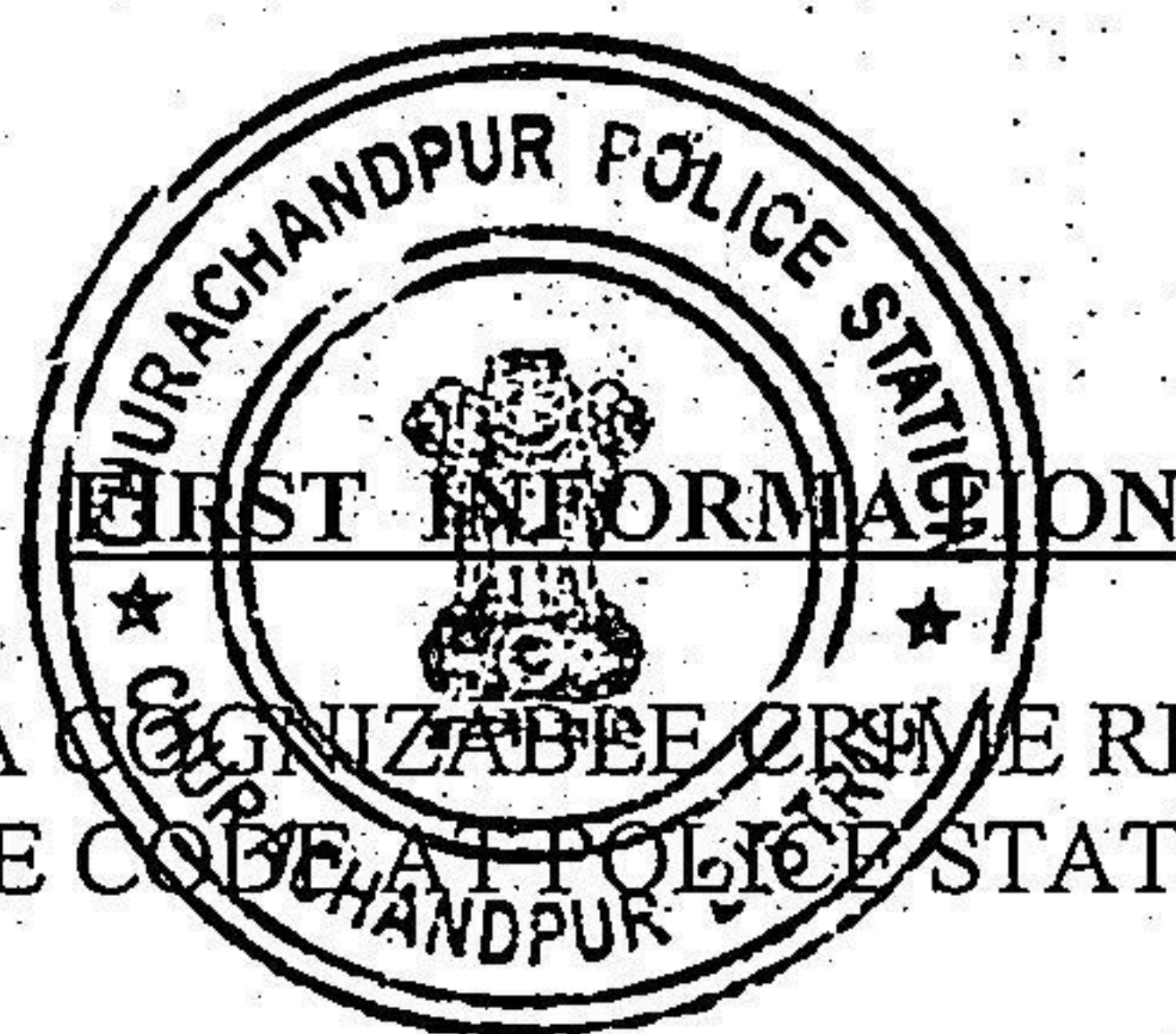

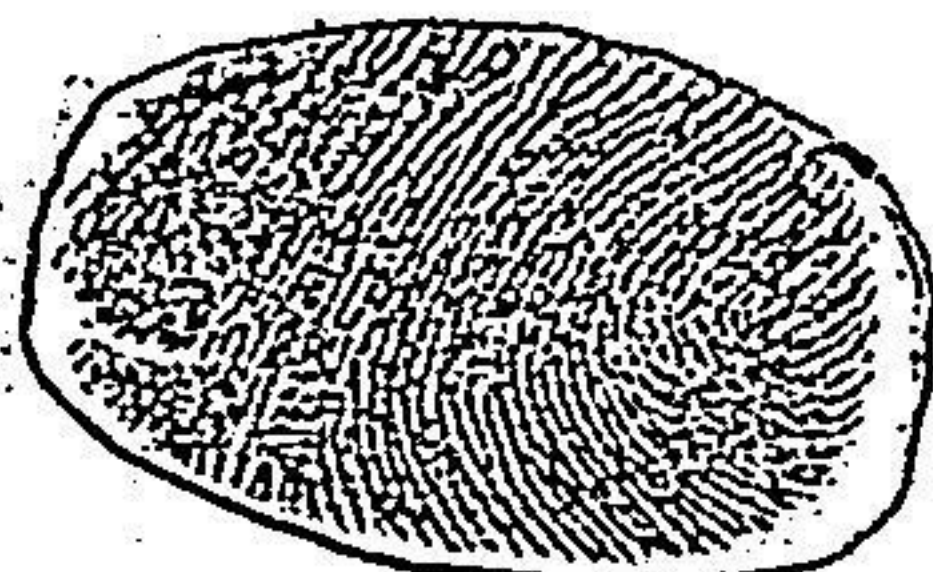

Due to the incident my household properties worth Rs.30,00000 Lakhs were damaged. We could not report the matter to Churchandpur Police Station due to the present Communal crisis.

You are therefore requested to take up the further necessary actions against the Culprits.
