

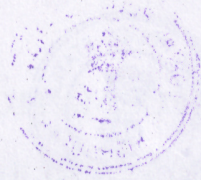

That I am a contract employee of NHPC Ltd Loktak posted at Power House Station NHPC Ltd, Leimatak for the last 9 years and the then manager of the NHPC Leimatak allowed me to stay at a quarter no. Type II/E-9 room no. 2, Leimatak.

That, on 07/05/2023, due to present communal Ethnic Clash in Manipur, I had left my quarter mention above leaving all my belongings like house hold materials, including kitchen items, electronic items, furniture items, family cloths items, equipment and tools.

On 20/11/2023 at around 1:00 PM, I came to know that all my left-out belongings were looted, stolen and destroyed my quarter mention above by unknown persons suspected to be Kuki resident of Leimatak & Kuki militants. The approximate value of my looted items Rs. 8,00,000/- (Eight Lakhs).

Hence, I sincerely request you to kindly take up necessary legal action against the culprit.


