That, on 07/05/2023, due to present communal Ethnic Clash in Manipur, I had left my quarter mention above leaving all my belongings like house hold materials, including kitchen items, electronic items, furniture items, family cloths items, equipment and tools.

On 20/11/2023 at around 1:00 PM, I came to know that all my left-out belongings were looted, stolen and destroyed my quarter mention above by unknown persons suspected to be Kuki resident of Leimatak & Kuki militants. The approximate value of my looted items Rs. 8.00,000/-(Eight Lakhs).

Hence, I sincerely request you to kindly take up necessary legal action against the culprit.
