

Sir,


With most respect and regard, I would like to state the following few lines for your kind attention.

That today i.e 27/11/2023 at around 10:30 am, I along with 4 Home Guard personnel including 2 contract labour were performed duties in the NHPC Water Supply (Pump House) at Awang Bazar. While performing our duty, 4 unknown persons in plain clothes came in the pump house campus and call up all our personnel including 2 labours in the barrack. They identified them self as NSCN(IM) and took all our mobile phones and put switched off all our mobile phones. Then they said that they are coming for their monetary demand which they have previously demanded to the official staff of NHPC, Loktak. And then 2 machine rooms also were locked and key and said if they did not response within 2/3 days, then they will do some criminal action. Then they left the place with mobile phones (Six nos.).

It is therefore, I request you to kindly take up necessary legal action against the culprit.
