

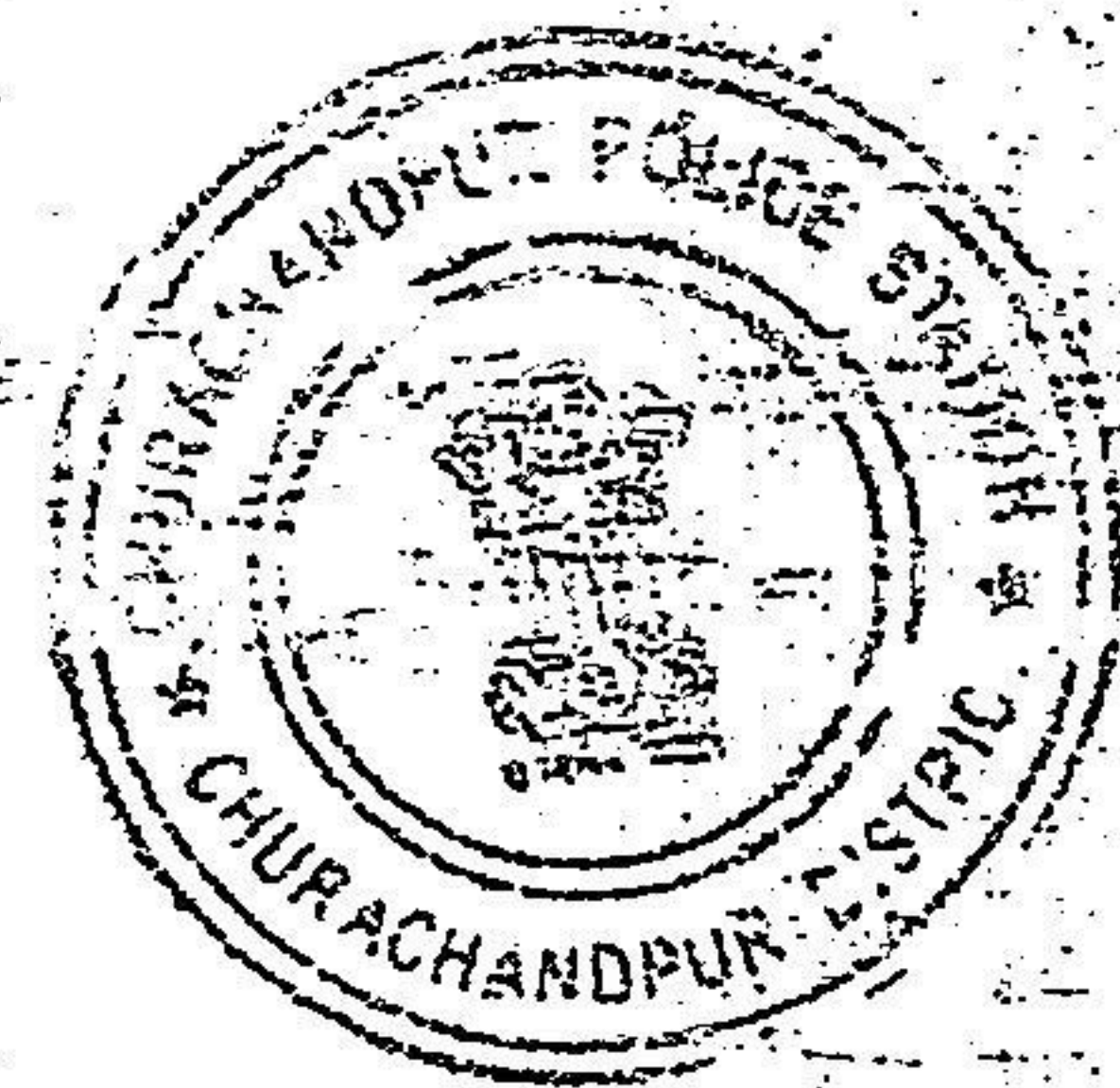

Sir,

I am to bring to your notice that on the 3<sup>rd</sup> May, 2023  
Between 7-8 PM, My Shop  
located at Teobung, C.P., P.O. & P.S. Churachandpur  
was attacked by a Group of Meeitei/Meitei's goons numbering 500 to 1,000 men.

These criminals broke open my gate(s) and looted every valuable property from my house and premises worth Rupees 45,00,000/- (approx..) and they burnt down all the remaining things.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive.

Therefore, with utmost Respect I request you to take strong actions against the perpetrators by registering an FIR under relevant sections of the Indian Penal Codes.
