

With due respect I would like to report a cognizable offence carried out against me and my families on 3<sup>rd</sup> May at around 9:00 Pm. wherein, a large gathering of mob of mainly Meitei Community who were suspected to be instigated and abated by Meitei Leepun & Arambai Tenggol of Valley based CSO's attack on my/our village TORBUNG and started vandalizing, ransacking and burnt down my/our HOUSE rendering me in a state of homeless person. Fearing to lose our lives and being in state of vulnerable, me along with my family/villagers numbering Male- and Female- had fled and now taking refuge and shelter at the resident/relief camp of PAOLUN village B. VENGOM. Churachandpur. Herein, are list of properties:-
