



Subject: Enquiry Report

Sir,

As endorsed to me, I would like to submit the details of the enquiry report in C/W with the missing report, Missing no. No. 1/LTK-PS/2023 Dtd 12/07/2023 vide GD entry no 9/LTK-PS/2023 dtd 12/07/2023.

That, the missing report was filed on 12/07/2023 by the daughter of the missing person. The complainant's name is Wahengbam Kajal Devi (18) D/O W. Jugin Singh (Missing Person) of Bishnupur ward no. 5 Bishnupur District Manipur, Pin -795126. When enquiring about the missing person Wahengbam Jugin Singh, it is learnt that the missing person has two wives. The first wife is Wahengbam Loidang Devi and they have three daughters and the second wife is Henei Khongsai of Kungpinaosen Village, Churhandpur District, under the jurisdiction of Loktak PS which is 22 KM North-West from the PS and the village is of Kuki Community. The second wife does not have any children. He has been staying with his second wife at Kungpinaosen village for more than 10 years. But they used to come at his home in Bishnupur from time to time. They were cultivating vegetables and collecting charcoal as their livelihood. As per the complainant, her father went out from Kungpinaosen on 27/06/2023 at his permanent residence at Bishnupur.

Further into the investigation, it is found that the last time the missing person and his second wife visited Bishnupur was on April 2023 for medical treatment of Wahengbam Jugin Singh. He along with his second wife was treated at District Hospital Bishnupur later which the family members drop them back to Kungpinaosen Village. As the communal clash started, the family members were not able to contact Wahengbam Jugin Singh or his second wife. Later they tried contacting one person namely Arangbam Kumar Singh who has a wife from Zoujangtek Village, but the person told the family that he also heard about Wahengbam Jugin Singh leaving Kungpinaosen Village and headed to Bishnupur. As he did not have much information about the missing person, he informed the family member to try speaking with Mr. Amu from Bishnupur ward no 2. who is a businessman and travels here and there throughout the villages.

Hence, the family went to meet Mr. Amu from Bishnupur ward no 2. Amu told the family members that he saw Wahengbam Jugin Singh from time to time when he passed the village and even had lunch at the missing person's home. However, after the communal clash started on 3<sup>rd</sup> May, 2023, he did not see Wahengbam Jugin Singh anymore. But one day he met the missing person's wife Henei Khongsai at Zoujangtek Village. When he enquires about her husband, Henei Khongsai was in tears and request him not to ask about her husband anymore and left.

In the light of the above findings, it is highly suspected that the missing person might have been abducted or killed by Unknown Kuki miscreants. So, it is requested that a regular FIR be initiated into the matter and thoroughly investigated into.
