I hereby write this letter to draw your attention that in the past few days i.e., on the 3rd of May 2023 @ 8:00 pm, my fast food stall run on a rented room situated at Torbung village was attacked by a group of armed Meetei/Meitei radicals.

These criminal broke open my stall door and destroy my shop which was vandalized , looted and gutted/burnt down and all what is within the shop was lost to the said meetei/meitei armed radical groups illegal activities a total loss estimated to be at an amount of Rs. 2,00,000/- (Rupees Two Lakhs) Only.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at , Churachandpur College Relief Camp.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
