I, the undersigned, have the honour to state the following for your kind intervention and favourable action:


- 1. That I, Shri Genkholian S/o (L) Nangkhopau, aged about 69 years, belonging to the Vaiphei tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.
- 2. That, I am a permanent resident of Kanvai Village, P.S. Churachandpur, Manipur-795128, and that I am the Church Elder of Mizoram United Pentecostal Church, situated at Kangvai Village, Churachandpur, Manipur, and by virtue of which I am competent and authorize to file a complaint on behalf of the said Church.
- 3. That, at about 07:00 pm on the 3rd of May 2023 some armed radical mobs belonging to meetei/meitei community armed with sophisticated weapons, chanting anti-tribal slogan, barged into the church premise, and the said mob accompanied by state forces posted at various valley based police outpost destroyed, vandalized, looted and burnt/gutted The Mizoram United Pentecostal Church Semi-Pucca building/structure and all its assets situated within the church building and all what is within the premise was all lost, a loss estimated to be at an amount of Rs. 55,00,000/- (Rupees Fifty Five) approximately was loss due to the illegal activities of the said mob.

Being a victim of ethnic attack by the dominant and majority Meiteis, I am filing this report with a request to kindly take necessary legal action against the perpetrators as per law.
