First Information Report on Injury due to commotion created by unruly goons and Deliberate Firing made by Radical Armed Meitei Persons abetted by a group of personnel wearing Police Commando's uniform with full combat belonging to a Meitei/Meetei Community upon unarmed Civilians.

Sir/Madam,

That, I, the undersigned, who belongs to "Paite" Community which is one of the recognized tribe within Manipur State, may be allow to bring to your kind attention that on the 28th May, 2023 at around 8:55 P.M, while coming back after visiting one of my friend at Kangvai Village has sustained injuries in my **Laceration over right upper back, Laceration at Planter aspect of left foot, Abrassion at B/L Knee Lat aspect of Rt arm** on account of the commotion created by unruly goons and Deliberate Firing made by Radical Armed Meitei Persons abetted by a group of personnel wearing Police Commando's uniform with full combat belonging to a Meitei/Meetei Community from the side of Phouchakhai (norther side of Kangvai) upon unarmed Civilians.

That, the deliberate action of the abovementioned perpetrator(s) has cause immense mental and physical trauma to me and my well-being. I am presently undergoing medical treatment due to the said bullet injury.

Under the circumstances, I request you to kindly look into the matter and register FIR under the relevant provisions of law against the perpetrator(s), investigate the matter at the earliest and booked the culprit(s) according to the law of the land.
