

Subject:- Report on burning of individual owned commercial vehicle.

Sir,

I, the undersigned, have the honour to state the following for your kind intervention and favourable action praying for registering an FIR and investigate the matter by due process of law:

1. That, I Smt Boijem Gangte W/o Genkholian, aged about 43 years, belonging to the Vaiphei tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.
2. That, I am a permanent resident of Kangvai Village, P.O./P.S. & District Churachandpur, Manipur-795128 and now currently taking refuge at YVA relief Camp, Hiangtam Lamka, Churachandpur-795128.
3. That, at about 07:00 pm on the 3rd of May 2023, some armed radical mobs belonging to the meitei/meitei community armed with sophisticated weapons, chanting anti-tribal slogan, burnt/torched/gutted my commercial vehicle owned and registered in my name of Mahindra Make, Jeeto Model, bearing Reg. No. MN06T 1536 at Kangvai Bazaar, an approximate valuation of Rs. 4,50,000/- (Rupees Four Lakh Fifty Thousand) only.

That, in view of the above stated facts and circumstances, being a victim of a communal/ethnic clash spearheaded by the majority meitei/meitei community, I am filing this report with a request to kindly take necessary legal action against the perpetrators as per law.
