Report on unlawful assembly, promoting enmity between different groups on ground of religion and race, uttering words etc with deliberate intent to wound the religious feelings of any person, Attempt to murder, Thest in dwelling house etc, Robbery, Dacoity, Mischief, House breaking/trespass and Criminal intimidation committed by the unruly goons of Meetei/Meitei Community.

Sir/Madam,

I have the honor to state the following few facts for your kind perusal and necessary legal action.

That, on the 3rd May,2023 at around 7-8:00 PM, while I am staying with my family at my/our residence (Patta recorded in the name of myself) situated at Torbung Village, Kangvai Sub-Division, P.O. Kangvai, P.S. Churachandpur, Manipur, some miscreants and unruly goons belonging to the Meitei/Meetei Community coming from the surrounding Meitei villages by chanting a slogan like "Kangleipak na yay pha re" and "Hao Hatlo" with a deadly weapons like sharp iron rod, Sword, Dow, Knife, Sticks and Automatic Rifles has attacked and torched my dwelling place along with 2(two) other residence/dwelling place belonging to my elder son namely Shri Houginlun Vaiphei (presently working in Hotel Industry at Shillong, Meghalaya) and my younger son namely Shri Lunchungnung Vaiphei (serving in the 6th Assam Rifles, presently posted in the state of Arunachal Pradesh, India). They even robbed and stealth the remnants thereby bringing disgraceful to the prevailing humanity a mankind has pursued ever and anon.

That, these Meitei/Meetei unruly goons broke open my door(s), robbed, looted, destroyed and burned down every valuable movable/immovable property(s) and valuable documents from my dwelling place and premises and also my son's dwelling place and premises including domestic animals (4 No. of Pigs) worth around Rupees 98,00000/-(Approx.). It may be pertinent to mention here that I am left with nothing as I had to run for my life with a narrow escape. I am presently taking shelter at Torbung Bazar, Kangvai Sub-Division, Churachandpur, Manipur.

Now, therefore, with outmost respect, I request your good office to take strong actions against the perpetrators by registering an FIR under the relevant provision of law (to mention some relevant sections are Sec. 143, 153A, 153B, 298, 307, 379, 392, 395, 397, 436, 440, 449, 450 and 506 of Indian Penal Code), investigate the matter at the earliest and booked the culprit(s) according to the law of the land.
