Your timely actions would be highly appreciated.

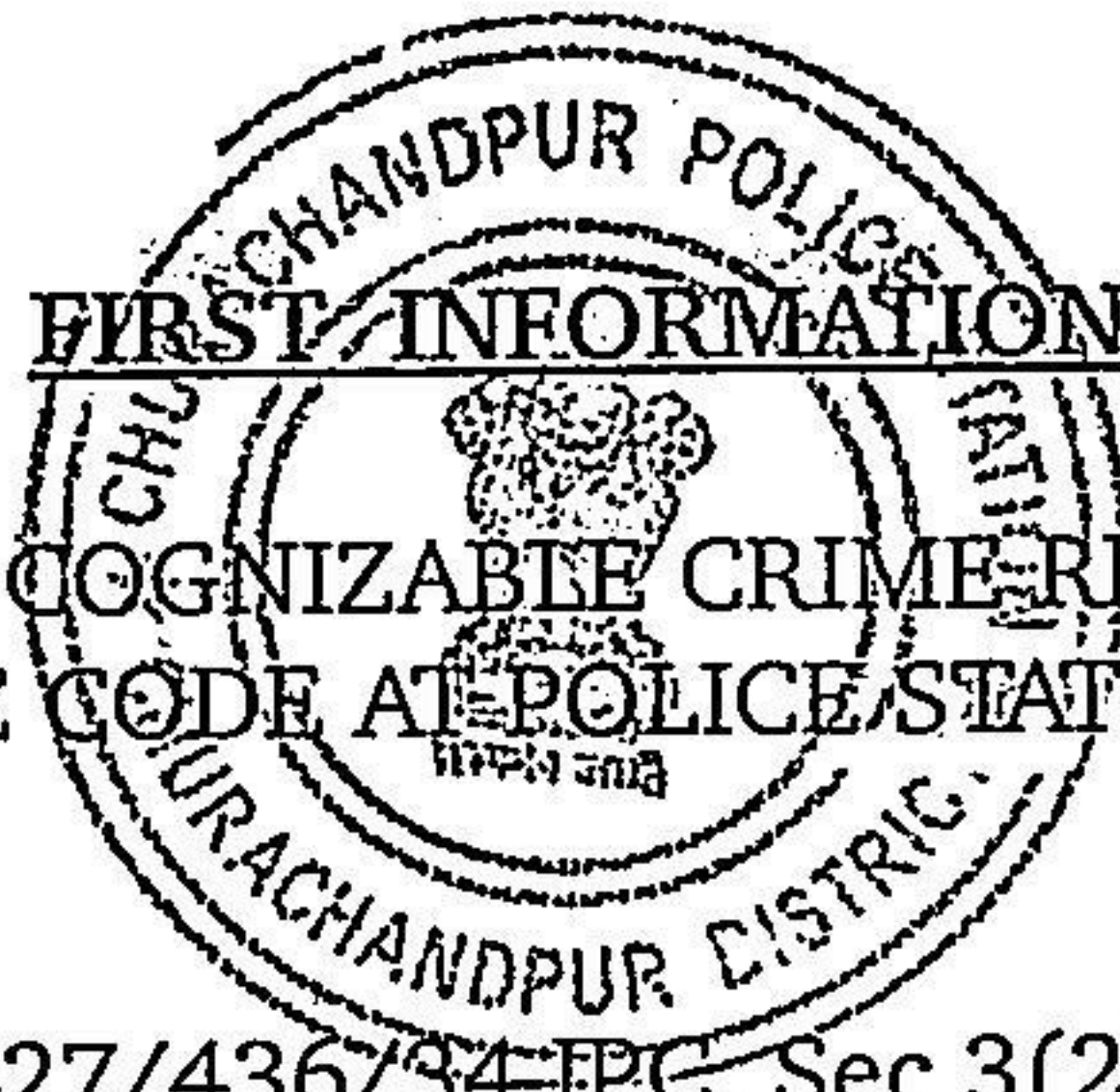


