With due respect, I am the chief of TL Gamngai Village, PO & PS — Churachandpur, District — Churachandpur.

That,I would like to inform and register a cognizable offenses carried out against me and my villagers in the intervening night of 4<sup>th</sup> May May, 2023 at around 9:00 Pm by Meitei Community, Who were armed with sophisticated automatic guns like AK's, Rifles, Pistol, Machette and knife whom were suspected to be instigated and abated by Meitei Leepun and Arambai Tenggol of valley based CSOs.

Due to such attacked carried out against my village and villagers, as such being in state of vulnerable. I and my family along with villagers numbering male-17 and Female-32, had fled from our village fearing to lose our life.

As such, we have been taking shelter at relief camp of Lydia Resource Centre, nearby Samaritan Hospital, Churachandpur District.

On inquiry, 19 (Nineteen) household were ransacked, torched and burned. Domestic animals were killed and taken away; properties were looted and taken away rendering my village at helm.

Therefore, I seek your kind intervention to register an FIR against the perpetrator and abettor who commit such heinous act upon me and my villagers for the end of justice.
