by the Armed Security Forces upon the unarmed civilians.

Sir/Madam,

That, I, the undersigned, who belongs to Schedule Tribe (ST), hailing from a Simte Community, which is one of the recognized tribes/Community of Manipur, may be allow to bring to your kind attention that on 05.05.2023 at around 9:30 P.M, My son namely Mr Johnlianmang (aged about 18 years), S/o Shri Tualkhozam, a permanent resident of V. Munhoih, New Lamka, P.O. & P.S. Churachandpur, Dist: Churachandpur, Manipur, who is a bystanders **sustained bullet injuries in his left leg** on account of the deliberate firing made by Armed Security Forces upon the unarmed civilians near Venus Hotel, Teddim Road, New Lamka, Churachandpur, Manipur.

That, the deliberate action of the Armed Security Forces has cause immense mental and physical trauma to our well-being. My son is presently undergoing medical treatment due to the said bullet injuries.

Under the circumstances, I request you to kindly look into the matter and register FIR under the relevant provisions of law against the erring Armed Security Personnel(s), investigate the matter at the earliest and booked the erring personnel/official(s) according to the law of the land.

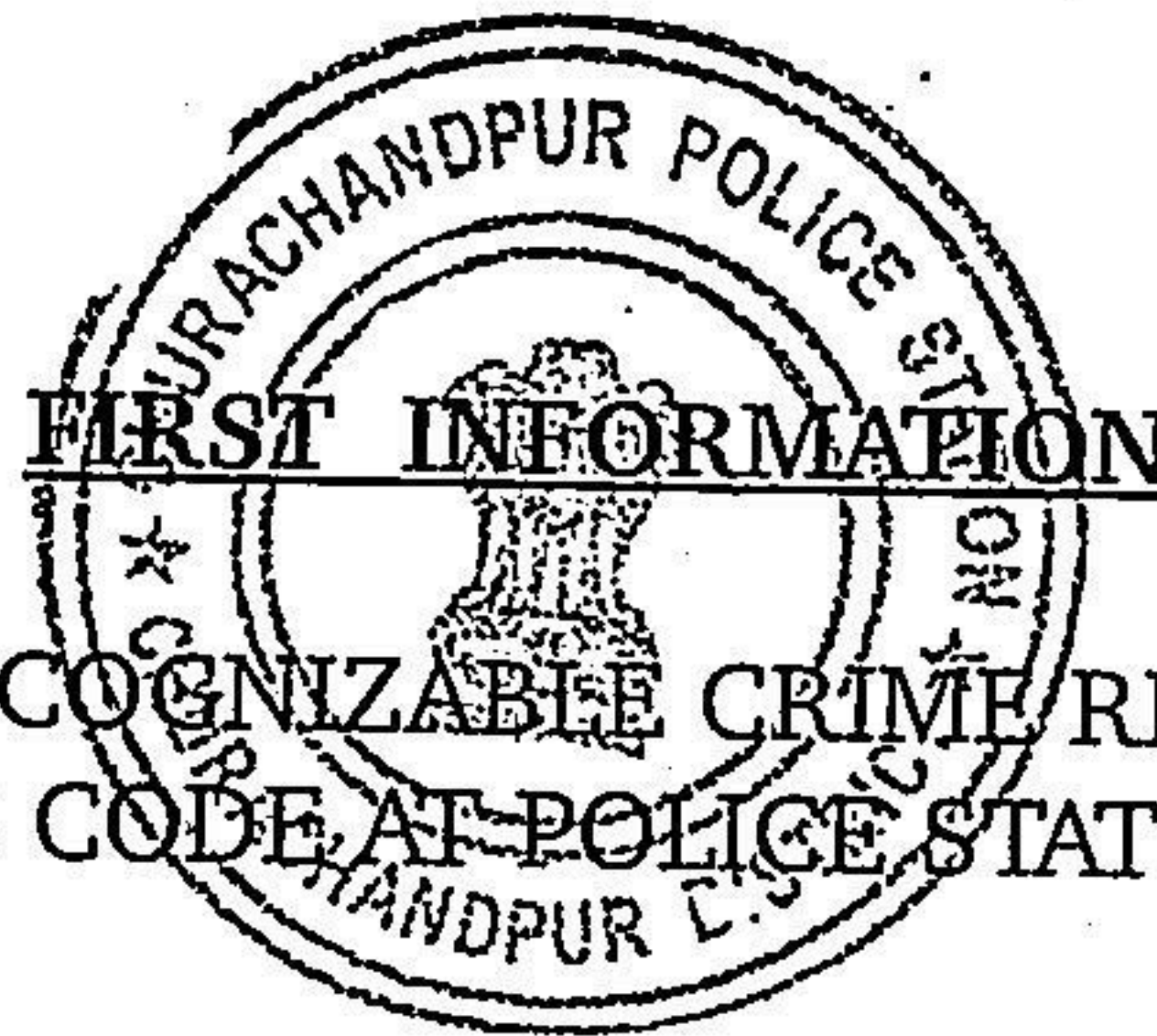
