Jamkholun, a permanent resident of V. Munhoih, New Lamka, P.O. & P.S. Churachandpur, Dist: Churachandpur, Manipur, who is a bystanders sustained bullet injuries over his left thigh on account of the deliberate firing made by Armed Security Forces upon the unarmed civilians near Venus Hotei, Teddim Road, New Lamka, Churachandpur, Manipur.

That, the deliberate action of the Armed Security Forces has cause immense mental and physical trauma to our well-being. My son is presently undergoing medical treatment due to the said bullet injuries.

Under the circumstances, I request you to kindly look into the matter and register FIR under the relevant provisions of law against the erring Armed Security Personnel(s), investigate the matter at the earliest and booked the erring official(s) according to the law of the land.
