SUBJECT: Report regarding bullet injury.

Sir,

I have the honour to lodge First Information regarding a bullet injury caused to me on 03.MAY.2023 at Zoveng, Churachandpur District, Manipur and hereby submits as follows:

1. That, I belong to the Scheduled Tribe, ZO TRIBE domiciled within Churachandpur District, Manipur.
2. That, at around 11:30 PM on the night of 03.MAY.2023, I, along with a few fellow volunteers while defending our Village, i.e., Kamdou Veng near Zo Veng, some Meitei Militants opened fire towards us.
3. That, the said Gunshot aimed towards us which was fired from sophisticated guns used by Meitei Militants hit me on my Right Knee.
4. That, the said injury resulted in bullet being stuck on the bone of my knee for which I already undergoes surgery on two occasions and the bullet was successfully removed during the second surgery.

It is therefore my sincere prayer that, the said incident may be investigated upon, the culprit be booked and a befitting punishment may be given in accordance with the law.

Thanking you for your humble assistance towards upholding the rights and dignity of the weaker sections of the society.

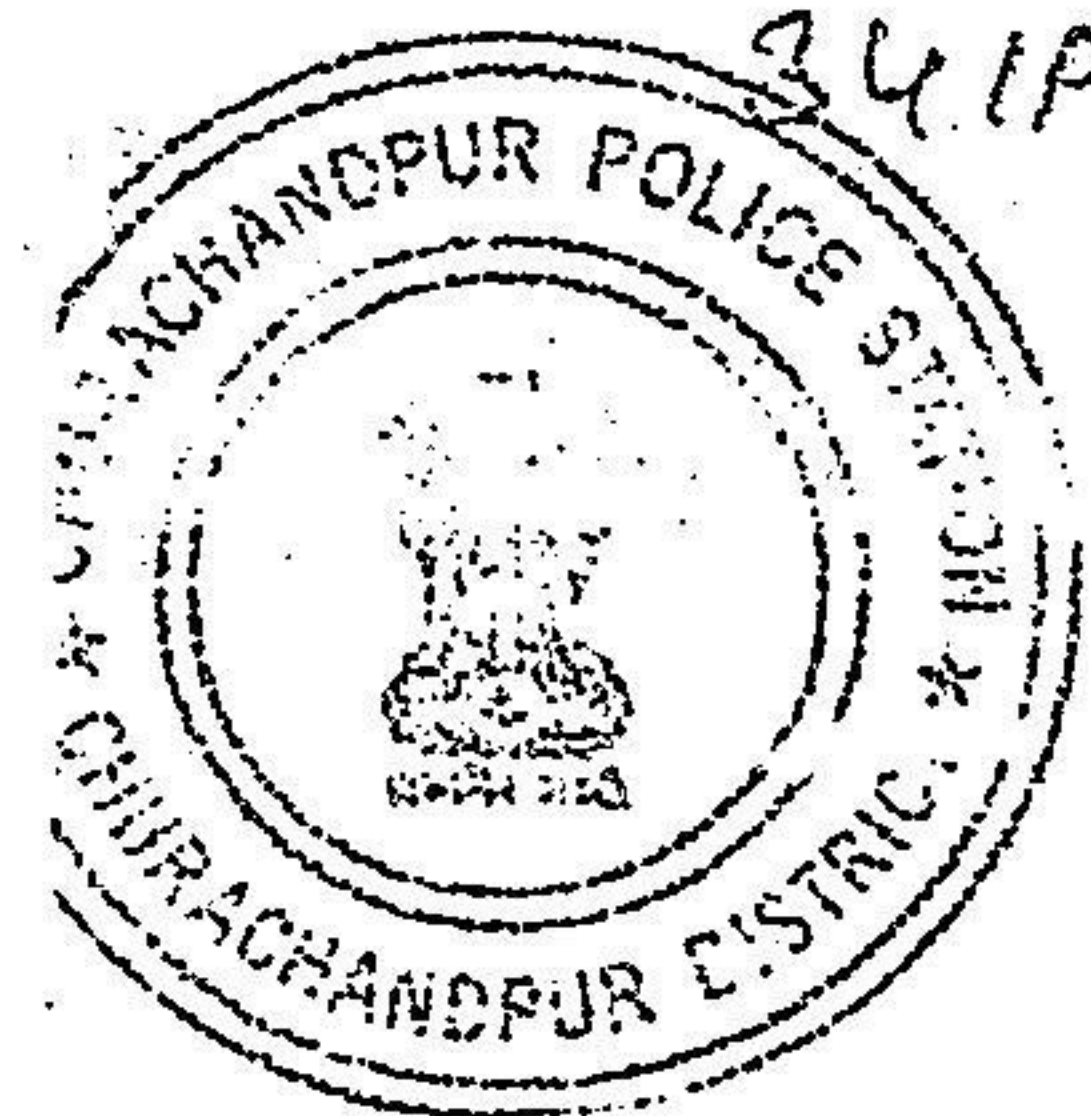

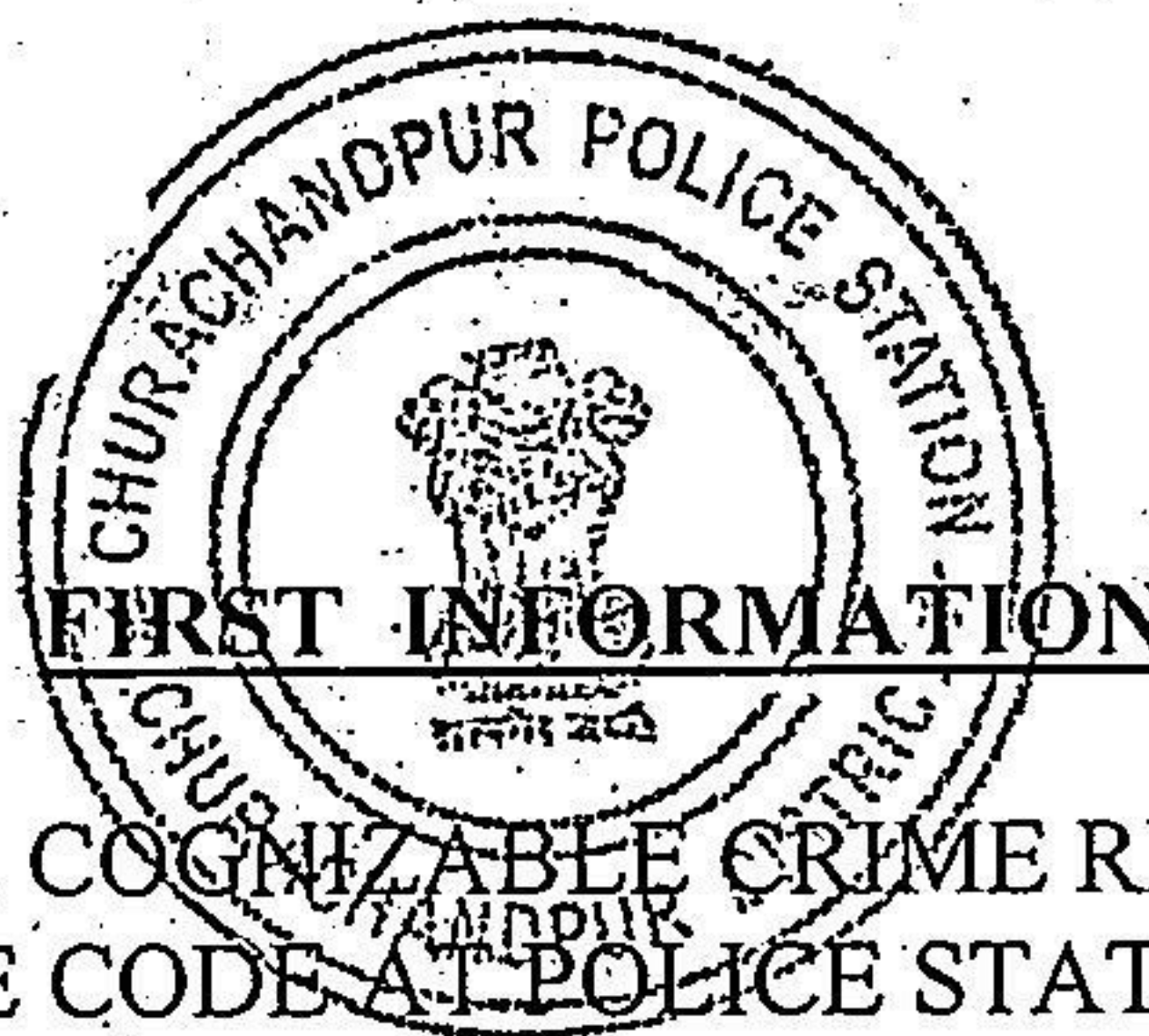
