Madam,

I have the honour to lodge First Information regarding a bullet injury caused to me on 05.MAY.2023 in front of Hotel Venus, Tedim Road, New Lamka, Churachandpur District Manipur and hereby submits as follows:

- 1. That, I belong to the Scheduled Tribe, PAITE TRIBE domiciled within Churachandpur District, Manipur.
- 2. That, at around 8:45 PM on the night of 05.MAY.2023, I, along with other women folks of my locality, was on my way to defend our fellow tribals stranded at Imphal due to the ethnic cleansing movement of the Meitei against Tribals.
- 3. That, at around 9:00 PM certain Military Personnel suddenly open fire towards unarmed women folks who are standing in front of Hotel Venus along Tedim Road, New Lamka, Chrachandpur, Manipur without any warning.
- 4. That, during that time, I got injured by a gunshot pointed towards the unarmed innocent women folks and open fired by Military Personnel. The said Gun Shot resulted in causing a bullet wound at my Right Wrist/Hand and my bone got fractured by the said gunshot.

It is therefore my sincere prayer that, the said incident may be investigated upon, the culprit be booked and a befitting punishment may be given in accordance with the law.

Thanking you for your humble assistance towards upholding the rights and dignity of the weaker sections of the society.
