Subject: First Information Report on Bullet Injury due to Gunshot(s) by the  
Radical Armed Persons belonging to a Meitei/Meetei Community upon  
unarmed Civilian.

Sir,

That, I, the undersigned, who belongs to "Paite" Community which is one of the recognized tribe within Manipur State may be allow to bring to your kind attention that on 03.05.2023 at around 7:30 P.M, I, a bystanders sustained bullet injuries in my head, left leg and left shoulder on account of the deliberate firing by suspected Radical Armed Persons/Militants belonging to the Meitei/Meetei community who are hiding and taking shelter inside Thengra Leirak Meitei Leikai, Churachandpur, Manipur

That, the deliberate action of the suspected Meitei Militants has cause immense mental and physical trauma to me and my well-being. I am presently undergoing medical treatment due to the said bullet injury.

Under the circumstances, I request you to kindly look into the matter and register FIR under the relevant provisions of law against the perpetrator(s), investigate the matter at the earliest and booked the culprit(s) according to the law of the land.
