These criminals destroyed and looted every valuable property from Lailampat Sericulture cum Holti FCS Ltd. worth Rupees 1 Crore (approx..) and they burnt down all the remaining things.

Therefore, with utmost respect I request you to take strong actions against the perpetrators by registering an FIR under relevant sections of the Indian Penal Code.
