

These criminals broke open my gate(s), destroyed and looted every valuable property from my Dairy Farming under Co-operative Society Regd. No. 18 of 2012 worth Rupees 1 Crore. (approx...) and they burnt down all the remaining things.

Therefore, with utmost respect I request you to take strong actions against the perpetrators by registering an FIR under relevant sections of the Indian Penal Code.
