Subject: Report on criminal intimidation, vandalism, looting/robbery and burning of Church of Christ Chapel that took place on 4th May, 2023 at about 01:00 AM at Seitol Khunou within Phongakchao Ikhai P.S.

Sir,

I, the undersigned, a member and victim of the said Church and presently taking relief / shelter at Mission Veng, Hiangtam Lamka have the honour to state the following for your kind intervention and favourable action that, on 4th May 2023 at about 1:00 AM, unknown Meitei goons armed with deadly sophisticated weapons came to our village wherein we all ran and hide in fear of our lives. As we ran and hide, the said Meitei goons entered our Church chapel and looted/ robbed all the valuable items and vandalized our newly built church and burnt down the old church with all the remaining materials/ goods including the Church.

- (1) Immovable property 2 Nos. Church building (Old and new).
- (2) Moveable property (i) All church properties inside the Church Chapel

That, the estimated value of properties both moveable and immovable destroyed, looted and burnt is estimated to be worth approximately Rs. 27,00,000/- (Rupees Twenty-seven Lakh) only.

As our Church Chairman and we are being displaced at different places, I on behalf of the said Church filed this report at the nearest Police Station and therefore request you to kindly take necessary legal action against the said culprits as per law.
