In the midnight between 3rd and 4th May, 2023, a large numbers of Kuki community backed by many armed personels suddenly attacked at our village, Tibong Village near SP Office thereby my house and properties worth about Rs 10890000/- (One crore nine lakh ninety thousand) has been completely damaged. Then the said community threatened to kill all Meitei/Meetei inhabitants of the said village. Therefore, all the villagers of the Meitei community were fleeing away and we all coming towards Imphal. And at present my family is now taking shelter at Heingang Kontha Makha Leikai Model Club, Relief Camp, Imphal East, Manipur.

I, therefore, request you to kindly take up necessary action by lodging FIR against the Kuki culprits at an early as possible.
