Sir,

I, the undersigned have the honour to state that a large number of innumerable unidentified groups of people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant group (s) stormed the Meitei inhabited area (s) of Churchandpur town on 3rd day of May, 2023 at around 4:30 pm . The said unidentified groups vandalised my Quater located inside the campus of Churchandpur Police Station and looted all valuable items. In that unfortunate incident, I have lost our house and property amounting to a total amount of about Rs.500000/- (five lakhs). After the said unfortunate incident/mob. I along with my family member fled way from Churchandpur to a relief camp with the help of Assam Rifles. Now I am staying at my permanent residence located at Iramsiphai Awang Leikai.

It is therefore, requested kindly initiate and take necessary legal action (s) against the accused people and the persons involved in the said inhuman acts and heinous crime as per law of the land as early as possible. I couldn't be able to submit my complain report in time due to some inconvenient situation.

I shall forever be grateful for your kind co-operation and necessary action.
