Subject:- Request for lodging of FIR case regarding looting and ransacking of my jewellery shop located at Churachandpur old Bazar on 3rd May, 2023.

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including kuki militants groups stormed to all Meitei inhabited areas of Churachandpur old Bazar on 3rd May, 2023 at around 11:00 pm. The said unidentified groups vandalised my jewellery shop and looted all valuable items of my jewellery shop namely "Sharmila jewellery" located at Churachandpur old Bazar. In that unfortunate incident, I have lost gold ornament/ silver (chandi) ornament worth Rs. 70,00,000/- (seventy lakhs) approx. Their illegal act lead many properties turned into ashes and disturbing peace and tranquilities to the general public heavily.

It is therefore, prayed that the respected Sir may kindly initiate and take necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land at the earliest.
